#### Composition of the PROLOGUE User Forum per February 2010

In February 2010 the PROLOGUE User Forum consisted of 109 members.

#### Type of organisation

Approximately one quarter (27%) of these members represent a non-governmental organisations, one quarter (28%) a private company, one quarter (21%) a public organisation and one quarter (24%) work for universities.

Looking at the nature of the potential stakeholders, the private companies are underrepresented. That is probably because the PROLOGUE consortium has a bias towards research organisations. New members from the private sector will be actively recruited in the near future.

#### **Countries**

The 109 User Forum members originate from 21 countries or represent a European/Brussels-based organisation:

The most prominent in this respect is the high number of Dutch and the low number of French members. Scandinavia, is well represented (12%), Western Europe (Belgium, France, Germany, Netherlands, UK) is somewhat overrepresented (40%), Southern Europe (Greece, Israel, Italy, Portugal, Spain) has a fair share (21%), Eastern Europe (Estonia, Hungary, Poland, Russia, Slovenia) is underrepresented (6%) and Central Europe (Switzerland, Austria) have a fair share as well (7%). In general, the representation from North to South is pretty good; from East to West there is a focus to the West.

There is a strong bias towards research (43%) which can be explained by the research-oriented PROLOGUE consortium as well as the fact that naturalistic driving still is in a (fundamental) research phase. The EU seems underrepresented (2%) but in the categories 'other' and 'road user organisations' quite a few members take part as a lobby in European policy making. The automotive sector (13%) is also underrepresented, especially since only 4% comes from OEMs (original equipment manufacturers). Also members specialised in 'environment' (4%) and 'traffic management' (2%) are still scarce in the User Forum.

#### **Conclusions**

As per February 2010, all relevant stakeholders are represented in PROLOGUE's User Forum. However, the distribution is biased towards road safety, research and Western Europe. The User Forum will be open for new memberships for the full duration of the project (July 2011). Via the website, direct contacts, PROLOGUE's regional workshops, and by drawing attention to the User Forum at all relevant occasions, this initial bias should be overcome. Specific focus will be on additional members from France and Eastern Europe, the automotive sector, especially OEMs, and organisations with a special interest in the environment and traffic management.
