Delay in WP3	TOI launched an assessment questionnaire to investigate the trajectory of the WP3-process in order to provide the coordinator, the consortium and the EACI with a clear understanding of the workflow. Based on those results we can generally say that the majority of the delay can be attributed to underestimated workload concerning the development of the modules. Next to that, as mentioned above communication was sometimes slower than agreed and deadlines were missed, which contributed to the delay as well.

# 2 Consortium management in the period

### 2.1 Contractual, financial and administrative coordination

The Coordinator keeps track of all administrative or financial questions and liaises with EACI if necessary.

### 2.2 Communication

#### 2.2.1 Between partners

The main instruments for formal communication between partners are the consortium meetings. The TOGETHER-consortium keeps meetings short and productive and regards them as joint working meetings instead of reporting meetings. Agendas are sent through well in advance.

Next to the consortium meetings, TOGETHER uses phone conferences to monitor workflow on specific points. There were 4 phone conferences held in the reporting period.

- 4. Telephone conference 22/03/2013

Last, the consortium keeps in regular contact via e-mail and telephone. Thanks to the fact that TOGETHER is a small consortium, every partner can be involved and is aware of on-going activities. Minutes are made for each face to face and telephone meeting.

#### 2.2.2 With the EACI

M21 maintains a good and satisfying communication with EACI via e-mail and telephone. However, during the reporting period TOGETHER's PO was replaced which made communication about the Interim Report a bit difficult.

### 2.3 Quality Assurance

During the Kick-off Meeting, M21 suggested to have a peer-review system for all deliverables. This was agreed and implemented. Every partner was assigned to one or more deliverables to peer-review. M21 performs a last general quality check on all deliverables.

For public deliverables, JMP performs an extra language check to ensure well written English.

### 2.4 Partner issues

No partner issues were encountered during the reporting period.





### 2.5 Unexpected developments

#### 2.5.1 JMP

Sabrina Ishfaq was seconded to another organisation 2 days a week and her hours also reduced to part-time (3 days a week). This meant that she was only able to commit one day a week to TOGETHER. Peter Hardy, the Project Director assumed responsibilities where she was unable to attend teleconferences. Sabrina also had support staff who carried out various tasks in her absence.

Although JMP have done their best not to let this change affect the project, it will no doubt had delayed certain aspects of the implementation. Particularly those to do with non-formal training.

In addition to this, JMP Consultants Ltd has been acquired by another company. All staff and offices transferred to a new company, which still operates as JMP Consultants Ltd. This has not caused a disruption to the project in the UK.

#### Progress

The final set of the training materials (incl. ring folder and register set) has been delivered. Main country specific versions have been finalised (incl. language and adaption). Parts of Swedish and Austrian adaptions are still in progress.

#### Deviations

WP3 has suffered a delay. It already started with a delay because of WP2 being delayed with 4 months. The final set of English training materials has been delivered by M19.

The country specific materials suffered from a delay because of the following reasons:





- The higher quality and complexity of the training materials needed to ensure a much better acceptance within the target group and lead to a significant increase of work.
- Translation and country specific adaptions faced problems (e. g. for many partners translation budget was too narrow for the final amount of materials and finding adequate translators was difficult for some partners and caused delays). Country specific adaptions had to be added or revised by FGM to keep the quality of the materials.
- Intensive communication regarding feedback and corrections (sending out repeated instructions plans by FGM).
- Swedish materials suffered from a delay because of translation and adaption problems.
- The design of Austrian materials suffered from a delay because of aiming the target to deliver all designed country specific materials for the partners to keep the ongoing WP4-process. This approach was chosen as the Austrian partners already established the best sufficient connections for implementation.

#### **WP4: Implementation**

#### Progress

So far, only 3 partners have started delivering training; FGM AMOR, JMP Consultants Ltd and Mobiel21. Collectively, these partners have delivered formal training to 145 participants and non-formal training to 217. This equates to approximately 104 sessions and a total of 489 hours of training. A full overview is given in annexe.

FGM-AMOR has implemented all modules with a focus on the safe cycling module. They have so far reached 26 participants through formal channels and 121 participants through non-formal. This equals to roughly 44 sessions totalling 91 hours. Two groups have also been evaluated.

JMP has implemented the modules within 2 colleges in two parts of the UK, Peterborough and Goole. So far, in the UK only formal training has been implemented and between two colleges, a total of 119 migrants have been reached with approximately 44 hours of training between them. All modules have been covered. However, due to the formal system for practical sessions, no specific site visits/practical sessions have taken place. Cycle training has been offered through the local authorities and other practical elements have been set as homework.





Mobiel21 has so far delivered cycle training to 96 participants over 35 sessions. This has been possible through the Leuven Cycle School, which Mobiel21 has good links. Teaching of the other modules will start during the summer.

In Norway, some of the institutes that were approached with regards to teaching pulled out at the last minute and so implementation has been delayed. Other schools and institutions are being contacted and meetings are currently being held with some of them to discuss the project opportunities further.

So far, no training sessions have been held in Sweden.

#### Deviations

In Peterborough, JMP were working with Peterborough City Council to deliver and implement the travel training to non-formal groups. This involved working with the Community Cohesion Officer to contact groups and promote the training. Unfortunately, due to other work pressures, the Community Cohesion Officer could no longer dedicate time to this. JMP has continued to make contact itself with a number of community groups to make them aware of the learning materials, and some of the modules have been provided to groups. However, none of these groups, to date, have asked to formally be involved.

Through other project work, JMP is now working with Luton Borough Council to deliver the nonformal training. A train the trainer session will take place on 27 June. As a result of the change in area, delivery the non-formal training is behind schedule in the UK.

#### **Process evaluation**

Based on the discussion in the phone meeting of March 22, 2013, a short questionnaire concerning the production of the national versions of the training modules was made and sent to all TOGETHER partners. A short draft report based on the filled in questionnaires from five partners, was sent to the partners. Comments received from Mobiel21 were incorporated into this process evaluation report. The status of the modules was reported in the Oslo meeting early June 2013. Several national modules were not ready by this meeting.

#### Impact evaluation





Questionnaires in English for the impact evaluation, a short note on the procedure for the impact evaluation and spreadsheets for the processing of the questionnaires were sent to the partners in February 2013. The Wp5 leader has received no information from the partners concerning the data collection for the impact evaluation, even though 2 - 3 partners have implemented some training. A special follow-up of the situation in Sweden showed no training implemented by late May 2013.

#### Conclusions

Adoption of the modules to national conditions, translation, language level checks, proof-reading and corrections of Word files and PDF files have taken a lot more time than planned. At least three of the five partners returning the questionnaire have spent more time than their budgets allowed for the productions of the national versions of the modules. The delays of the national versions have implied a delayed start of the implementation of the training. Consequently, there will be less time than planned for implementation and assessment unless the project period is extended.

As implementation of training has been delayed because of late finalisation of training modules, impact assessment has been delayed as well

The website has been updated with all training modules in the partner languages. Also the evaluation questionnaires in different languages are online.

Next to that the Promotion Package (poster and leaflet) has been produced in English and different partners languages and distributed amongst the target group and relevant stakeholders. As it proved to be budgetary difficult to leaflets in languages of origin (Turkish, Moroccan, ... ), the leaflet is mainly targeted at intermediary organisations (schools, social organisations, grassroots organisations, ...) or higher educated immigrants.

All partners have started communication and dissemination activities. In annexe you can find an overview of the most important activities per partner. STA wasn't able to deliver this overview in time. TOI and AEA have started but indicated no activities to be reported yet.
